



CHILD PROTECTION POLICY (CPP) REQUIREMENTS

MAIN Adult Contact must have completed the following:

- ✓ Attended a 2 hour Initial CCP Training held by the Diocese of Belleville
- ✓ **If** that was over a year ago, has attended the 45 minute CPP Annual Refresher Course held by your parish Location Coordinator
- ✓ Has completed the DCFS CANTS for (1 page)
- ✓ Has completed the Belleville Diocesan Volunteer Application (5 pages), complete with references
- ✓ Has completed the State Background Check (1 page)
- ✓ **If** they have lived out of the state of Illinois in the past five years, has completed a Federal Background Check instead (1 page).

OTHER Adult Chaperones (including Drivers) must have completed the following:

- ✓ Attended a 2 hour Initial CPP Training held by the Diocese of Belleville (See Winter Schedule on back)
- ✓ **If** that was over a year ago, has attended the 45 minute CPP Annual Refresher Course held by your parish Location Coordinator
- ✓ Has completed the DCFS CANTS for (1 page).
- ✓ Has completed the Belleville Diocesan Volunteer Application (5 pages), complete with references.

****Please keep in mind that CANTS forms must be renewed every two (2) years, and Background Checks must be renewed every five (5) years.***

**** Youth Age 18 and older and no longer in high school who participate in Diocesan-sponsored youth ministry events must also be CPP compliant.**
